Don Harris gave a report on CFM that he attended last week and stated that they were having their 75th Anniversary this year. CFM was instrumental in getting the Department of Conservation established. The sales and regulations came from members and 32 resolutions were presented in the past. CFM membership is \$25/year. Don Harris has applications. The CFM Report is attached.

Frank thanked Don for his help and discussed the State Fair. Stan O'Daniel gave a history of the State Fair. Last year the Conservation Department cut back and quit funding the State Fair Activity for Hunter Education. It was hard to survive but MHEIA voted to fund it and Stan did most of the work with his partner resigning. He really had problems getting it set up but it finally came together and he had a lot of help from volunteers and Stan thanked everyone who did help to make it a success. Stan mentioned that the Conservation Department is still in a financial crunch Stan again thanked everyone for their help. Frank Powers mentioned that everyone should see Stan O'Daniel and Kenneth Clapsile to volunteer for help. The State Fair dates are Aug. 11th – 21st.

Frank Powers reported that there was no information on YHEC – Dave Brooks.

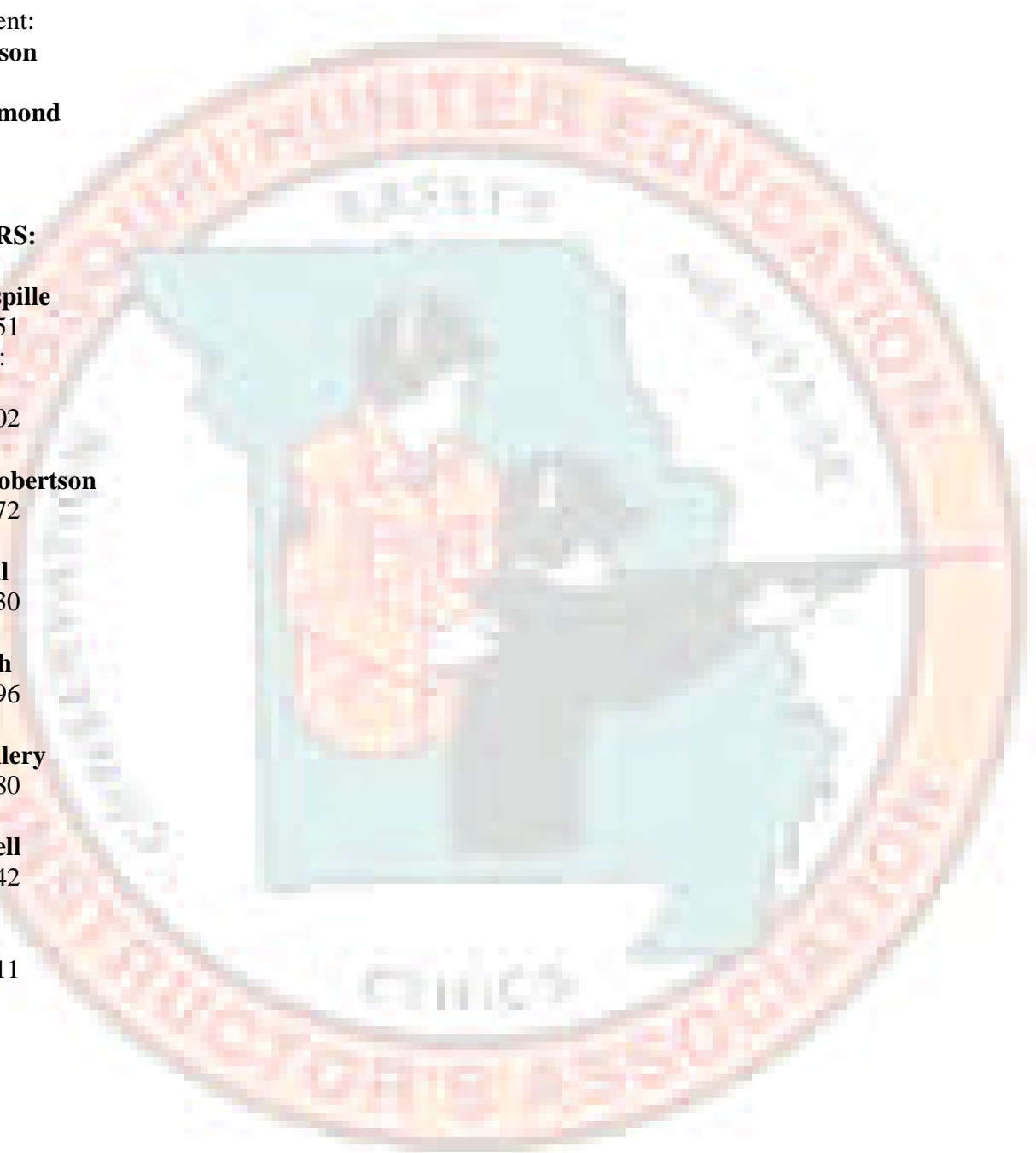

CFM HELD THEIR ANNUAL CONFERENCE LAST WEEKEND AT THE LODGE OF FOUR SEASONS IN LAKE OZARK, MO.

RESOLUTIONS ARE DRAFTED AND PASSED CONCERNING ISSUES OF INTEREST TO ANY MEMBER WHO WISHES TO HAVE THEIR ISSUE ADVANCED BY CFM.

RESOLUTIONS ARE PRESENTED TO THE PROPER NATURAL RESOURCE COMMITTEE THEN SUBMITTED TO THE RESOLUTIONS COMMITTEE AND FINALLY TO THE GENERAL ASSEMBLY FOR FINAL APPROVAL.

IF PASSED OUT OF THE GENERAL ASSEMBLY, IT IS THEN ADOPTED AS PART OF CFM'S OFFICIAL PLATFORM. CFM STAFF MAY TAKE FURTHER ACTION BY CONTACTING THE PROPER GROUP, AGENCY OR INDIVIDUAL TO INSURE THE ISSUE IS RESOLVED.

MDC TO ALLOW THE USE OF CROSSBOWS DURING ARCHERY DEER SEASON. (FAILED)

MDC TO ESTABLISH WORLD CLASS ARCHER RANGES USING FUNDING FROM THE PETTMAN ROBERTSON ACT. (PASSED)

MDC TO ESTABLISH A MENTORING PERMIT FOR OUT OF STATE HUNTERS AT A LOWER COST FOR MENTORING ONLY. (PASSED)

MDC TO PROVIDE MOUNTIAN LION EDUCATION FOR THE GENERAL PUBLIC. (PASSED)

TO OPPOSE HB 115 SPONSORED BY; RODNEY SCHAD PROPOSED THAT THE DEPARTMENT OF CONSERVATION SHALL HAVE OWNERSHIP AND TITLE TO ALL ELK IN MISSOURI, AND SHALL BE FINANCIALLY RESPONSIBLE FOR ANY DAMAGE CAUSED BY THEM. (PASSED)
