Meeting called to order by Vice President/ Acting President Jim Robertson.

Welcome extended to guest(s).

Agenda approved by unanimous vote.

Meeting minutes from Board Meeting of January 16, 2011 were tabled in the absence of the Board Secretary and copies of the minutes.

Don Harris reported that we only had 67 members at the Conference.

Treasurer's Report was given by Don Harris, Treasurer.

General Fund balance was \$2821.50. Smittybear Fund balance was \$1531.07.

Voted on and approved by unanimous vote.

Jim Robertson presented a proposal from The Inn At Grand Glaize in Osage Beach for our annual Conference. Discussion followed. The Association as well as attendees can save quite a bit of money if we move the Conference out of Columbia to Osage Beach.

Bob Mallery made motion for Jim Robertson to pursue this option and the authority to sign a contract with The Inn At Grand Glaize. Tim Moore made the second.

Motion voted on and approved by unanimous vote.

Don Harris gave Membership Report. The Association has 282 current members.

Newsletter presentation was give by Jerry Bryant & Tim Moore. Discussion followed about costs of Newsletter and its mailing. A May 17, 2011 deadline was set articles to be in, so they could be put into the Newsletter and get it mailed before the next Board Meeting in July, 2011.

Awards were discussed.
